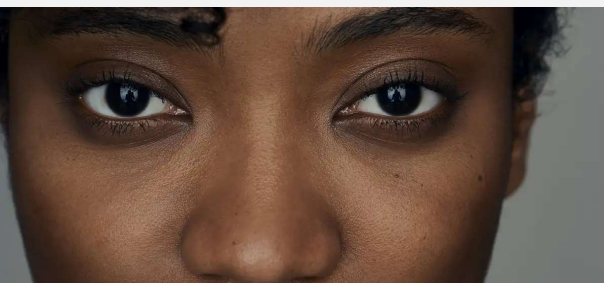

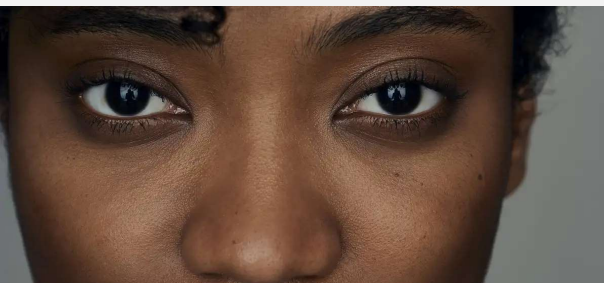

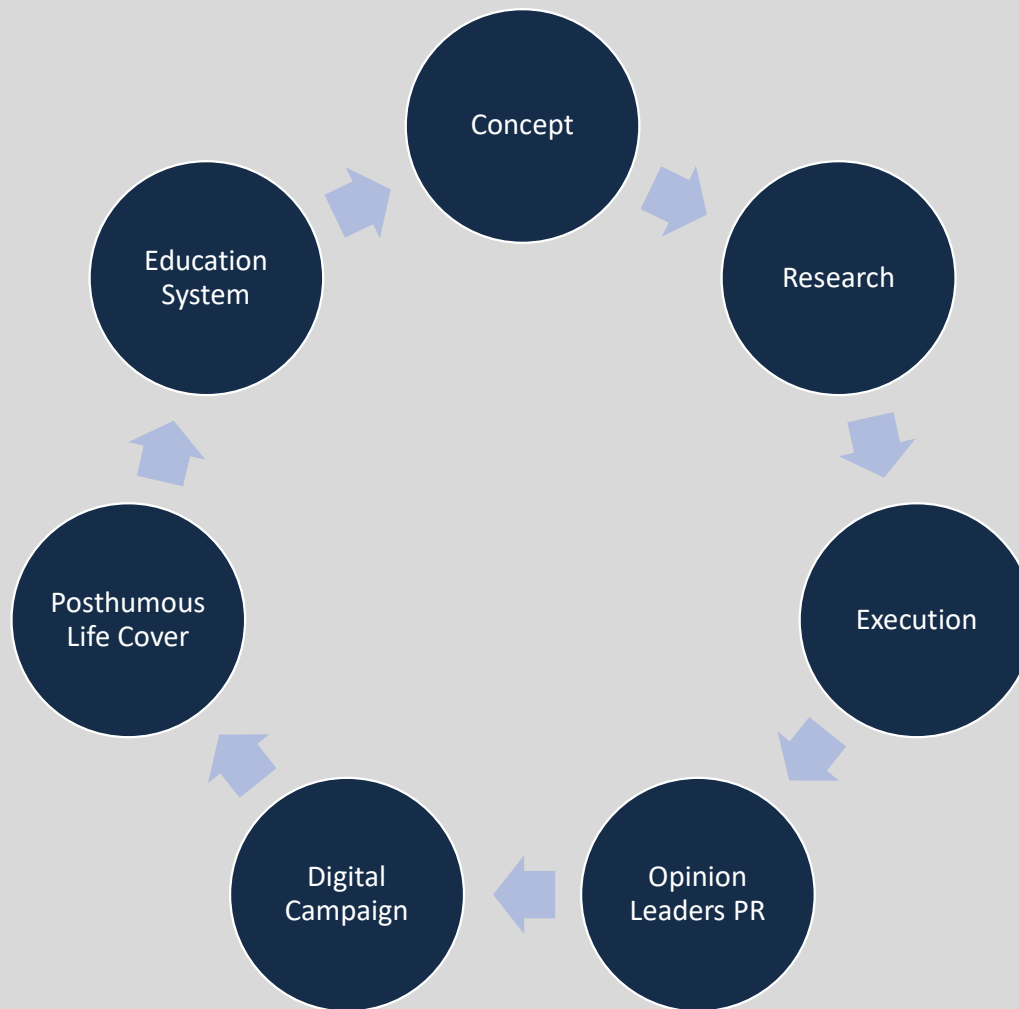

SONJA *Schlesin*

Although the South African College (presently UCT) allowed women to do certain law courses from 1857, it would be 75 years before the first female was conferred an LLB, and a further nine until women could practise the profession. A case in point of this gender discrimination is that of Sonja Schlesin, who played a significant role in the legal offices of MK Gandhi. With the Indian advocate's backing,

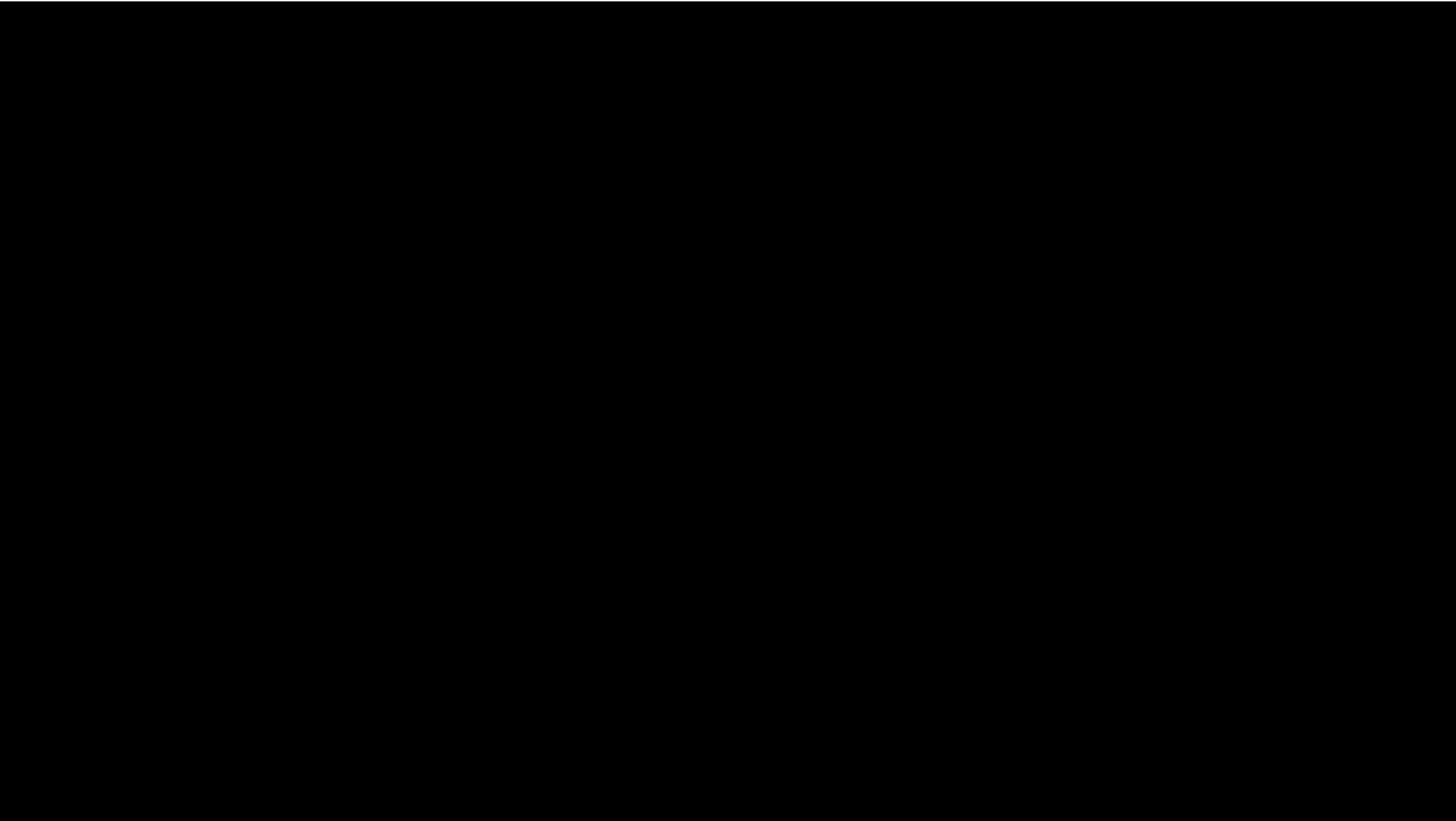
Schlesin went through the process of becoming a clerk, but on approaching the high court in 1909 to do her articles, the judgement went against her – on the grounds that 'ladies' could not be attorneys. In the early twentieth

century, a polemic that appeared on the pages of the South African Law Journal concluded that women were not suited to the profession of law due to a lack of competency in 'hard reasoning'.
